Bills are due upon receipt and considered past due if unpaid 26 days after the statement date. Late penalties are assessed after 30 days with customers given 60 days to pay any past-due amounts prior to water service disconnection. A 24-hour payment drop box is located on the water district office door, 22545 Del Oro Road, Apple Valley, CA 92308.
